aimed to unify clinical language into a structured, repeatable coding system. The CPT code—comprising numeric and alphanumeric identifiers—was designed to classify medical, surgical, and diagnostic services with granularity, enabling precise billing, statistical analysis, and insurance processing. Yet the CPT system's development was deeply embedded in the economic and political currents of post-war America. The expansion of employer-sponsored health insurance after World War II, coupled with the rise of managed care in the 1980s, intensified demand for standardized coding. Coding became not merely a medical function but a financial gatekeeper. The transition from paper records to electronic health systems in the 1990s and 2000s further accelerated complexity, as CPT codes were integrated into electronic health records (EHRs), clinical decision support tools, and automated billing algorithms. This digital integration, while increasing efficiency, introduced new layers of risk: code selection errors could cascade into denied claims, regulatory penalties, or even legal liability. Beyond the U.S., the evolution of medical coding reflects divergent health system models.
