This governance failure was not an anomaly but symptomatic of a wider trend in late-stage tech: the elevation of founder myth over institutional rigor. Expert analysis identifies WeWork’s downfall as a symptom of deeper, systemic issues in global capitalism. Economist Raghuram Rajan warned that the “cult of disruption” had incentivized growth at all costs, decoupling corporate success from sustainable value creation. Philosopher Byung-Chul Han’s critique of “excellence culture” resonates: the relentless pursuit of innovation, when unmoored from accountability, breeds moral hazard. WeWork’s branding—community, empowerment, transformation—masked a core ethical failure: the instrumentalization of employees and communities as collateral in the quest for scale. Coworking spaces, marketed as inclusive hubs, often became vehicles for gentrification, displacing small businesses and normalizing precarious labor conditions.
