The EU’s GDPR and HIPAA in the U.S. provide regulatory scaffolding, but enforcement gaps persist, especially with global health tech firms operating across jurisdictions. Algorithmic bias further complicates equity: AI trained on predominantly white, able-bodied populations risks misdiagnosing or underestimating functional needs in diverse groups—racial minorities, people with intellectual disabilities, or those with non-standard movement patterns. A 2023 study in *The*

**Lancet Digital Health\* found that a leading VR therapy platform underestimated fine motor recovery in patients with cerebral palsy, leading to under-prescription of care. Accessibility remains a structural fault line. While high-end VR systems and AI-powered analytics offer transformative potential, their cost and technical demands exclude millions. In LMICs, where 80% of people with disabilities lack access to basic therapy, technology often amplifies marginalization. Yet, mobile-first solutions—such as SMS-based cognitive exercises in rural Kenya or low-bandwidth apps using basic smartphones—demonstrate how frugal innovation can democratize care. These approaches prioritize usability over spectacle, aligning with the WHO’s ‘Nothing About Us Without Us’ principle. The challenge lies not in technology’s absence, but in its distribution: who controls development, and whose needs shape design? Global comparisons reveal divergent pathways. In Nordic countries, where universal healthcare integrates digital tools by policy, occupational therapy has embraced tech as a core component of preventive care. Norway’s national tele-OT program, launched in 2018, now serves over 15,000 rural patients, reducing wait times by 60%. Japan, facing one of the world’s oldest populations, has invested heavily in robotic exoskeletons and AI companions for elderly care, with pilot programs showing reduced institutionalization rates. In contrast, the U.S. model remains fragmented—private insurance variability, patchwork telehealth policies, and strong professional gatekeeping slow adoption. Emerging economies like Brazil and India are adopting hybrid models: public-private partnerships**

leveraging mobile health (mHealth) to scale services, though often constrained by infrastructure and training gaps. Long-term implications hinge on three interlocking domains: clinical efficacy, ethical governance, and systemic transformation. Clinically, the integration of real-time biometrics and adaptive algorithms promises a shift from reactive to predictive care—intervening before functional decline becomes irreversible.
