Achebe did not romanticize tradition nor condemn progress; instead, he exposed how the collapse of coherent governance created a vacuum filled by corruption, ethnic favoritism, and performative patriotism. This vacuum, Achebe argued, was not accidental. It was structural. The colonial state had never built institutions; it had engineered dependency. When Nigeria gained independence, it inherited a bureaucracy designed not for public service but for control—mechanisms that persisted

long after the departure of British administrators. As Achebe observed in essays like “An Image of Africa” (1975), African literature itself became a counter-force, a means to reclaim narrative sovereignty. But beyond fiction, Achebe’s activism through publishing—founding Heinemann’s African Writers Series—was a deliberate effort to reposition African voices within global literary economies. He understood that cultural representation was inseparable from political agency. “Who tells the story,” he warned, “controls the memory, and memory shapes the future.” Yet Nigeria’s trajectory since the 1960s reveals the limits of narrative alone. The Biafran War (1967–1970) crystallized the nation’s fragility—a conflict born not of ethnic essentialism, as simplistic discourses often suggest, but of systemic exclusion and the failure of federal compromise. The war’s aftermath entrenched a centralized state apparatus that prioritized oil revenue extraction over equitable development. The discovery of oil in the Niger Delta in the 1950s intensified this dynamic: resource wealth became a tool of elite capture, fueling militarism, environmental degradation, and intercommunal conflict. Achebe, who witnessed the war’s devastation firsthand, never wavered in his critique of a state that weaponized ethnicity to maintain power. The geopolitical dimension deepens this analysis. Nigeria's oil wealth has made it a focal point of great-power competition—from Cold War proxy rivalries to

contemporary struggles over influence in West Africa. Yet internal divisions, exacerbated by ethnic federalism and religious polarization, limit its ability to project stable authority beyond its borders. Achebe understood that national weakness invites external manipulation. “When a nation cannot govern itself,” he wrote, “foreign powers will step in—sometimes as saviors, often as exploiters.” The Boko Haram insurgency, banditry in the Middle Belt, and separatist agitations in the South-South all reflect not just local grievances but systemic failures rooted in state fragility. Economically, Nigeria’s demographic trajectory compounds these challenges. With over 200 million people, it is Africa’s most populous nation and a potential economic giant. Yet youth unemployment exceeds 36%, inflation spikes unpredictably, and infrastructure remains underdeveloped. The informal economy dominates, reflecting both resilience and systemic exclusion. Achebe’s vision of development was holistic: not just GDP growth, but the cultivation of a citizenry grounded in ethical leadership, critical consciousness, and cultural pride. Without this, economic opportunity remains uneven and unsustainable. Expert perspectives echo Achebe’s urgency. Historian Toyin Falola emphasizes that Nigeria’s crisis is “a failure of imagination”—a collective inability to envision and enact a shared future beyond tribal and regional divides. Political scientist Adekeye Adebajo notes that Achebe’s literary project was a form of “cognitive liberation,” a prerequisite for political transformation. “Books,” Adebajo observes, “do not change governments, but they change minds—minds that must lead to minds that must govern differently.” Controversially, Achebe’s legacy has been debated. Some critics argue his focus on cultural unity underestimates the legitimacy of ethnic identity

in a plural society. Others contend his optimism about Nigeria's potential was overly idealistic, neglecting the depth of institutional rot. Yet these critiques miss Achebe's core insight: the problem is not ethnicity per se, but the absence of inclusive institutions that mediate difference without violence. He did not deny conflict, but insisted on its resolution through dialogue, not domination. The risks Achebe identified remain acute. Yet there are signs of renewal. First, constitutional reform that redefines federalism not as competition for oil revenue but as a framework for equitable resource sharing. Second, investment in education that centers African epistemologies alongside global knowledge—producing leaders who think critically, not just instrumentally. Third, a cultural renaissance that celebrates diversity while affirming a shared Nigerian identity, not as a dilution of difference, but as a strength. Achebe's "trouble" endures because Nigeria's unresolved questions—about legitimacy, equity, and belonging—are universal. His work reminds us that national healing begins with confronting uncomfortable truths: that independence was only the start of a longer struggle, that cultural erasure is

violence, and that democracy is not a form but a practice. Nigeria’s future depends on embracing this rigor. As Achebe once wrote, “Until the black man sees himself as he is, he will never be free.” The struggle to define Nigeria—its meaning, its destiny—is the ongoing act of that self-seeing.
